The company LiptovTravel Ltd. is responsible for the procession of your personal information in accordance with the laws applicable within the Slovak Republic. Terms „we“, „us“, „ours, „LiptovTravel Ltd.“ used on this site are related directly to the company LiptovTravel Ltd. based on the context. The term „You“ relates to the person accessing and/or using our website. LiptovTravel Ltd. collects only the personal info you want to provide us, or info which is essential for us to provide (and improve) our services for you. The provider collects solely information stated in § 10. par. 3, letter d) Act no. 122/2013 Collection of Laws about privacy, i.e. „the subject of such a procession are solely title, name, surname and address of the person concerned without the possibility to add any further info and their use is solely reserved for the needs of the provider in a mailing relation with the person concerned and the registration of this information; if the subject of the activity of the provider is direct marketing, the stated information may be provided to other providers with the same activity solely for the purpose of direct marketing, while the person concerned has not applied, in writing, for the complaint according to § 28 par. 3. letter. c) Act no. 122/2013 about privacy protection. You can provide us with your e-mail address, name, phone number etc. so we could offer you information about our services, assign you to our competitions or surveys, or inform you about events and discounts of the LiptovTravel Ltd. company, which may be in your interest. We would like to assure you that LiptovTravel Ltd. undergoes all the necessary measures to preserve the protection and security of your personal data you provide us with, particularly:

1. Takes all the necessary measures to preserve the confidentiality and security of your personal information.
2. Access to your personal information are provided only to the authorized personnel of our company, which are further provided according to the law.
3. All authorized employees of our company who have the access to your personal information must comply with the Privacy protocol of the LiptovTravel Ltd. company.
4. We maintain safe IT environment and have prepared required measures to prevent any leakage of the personal information our company uses or processes.

5. Your personal information is processed only for the purposes you provided them for to the company. This information will be used to provide, for support and to obtain feedback about the level of our services and to prevent any breach of security, laws or our T&C.

6. Our company will never share your personal information with any other third-party company, which plans to use them for direct marketing purposes, unless you clearly consent to it.

7. The company may also share your personal information with third parties, but only under strictly limited circumstances which are allowed by the following quoted law: - We are authorized to share your personal information with third parties (such as providers of the same activity/interests as that of the original provider and to the operator of the internet services) , which help with managing the website based on a learning process.
